Discussion concerning registration restrictions on MAC courses. Council needs to define its criteria for MAC course proposals, student and advisor appeals and exceptions so that we have a set of standards to refer to for the committee and external observers. Council is concerned about breadth across disciplines. There is no policy to limit the number of MAC courses for a particular major. A point of MAC is to allow students to take courses that interest them, a wide variety is needed. Without a policy, students could possibly take most of their MAC courses in a single discipline. Suggestion to create a draft/template policy to address Council concerns.
