Informational item: A change to the admission requirements for the Interior Architecture, M.F.A. (removal of GRE requirement) was approved by the GCC on 11/4/2022. A program revision for the Accelerated B.F.A. to M.F.A. Interior Architecture was approved by the GCC on 11/30/22 but the revision did not remove the GRE requirement. Because the admission requirements for both programs must align and the GCC has already approved the removal of the GRE requirement for the Interior Architecture, M.F.A., Ian Draves will remove the GRE requirement for the Accelerated B.F.A. to M.F.A. before updating the program in the Catalog.

Discussion: curriculum process items

Jodi Pettazzoni reported that the Provost asked a subcommittee of deans to review academic efficiencies, and that one of the areas they focused on was curriculum review processes and deadlines. One suggestion to address their concerns is a possible electronic review of proposals that would occur in between committee meetings. Only minor revisions such as course title changes would be included in the electronic review (changes previously categorized as routine changes). The process would be a way to move items through the curriculum review process more quickly and free up meeting time. A small number of proposals (5-10) would be included in each set of proposals for electronic review. Close readers could be assigned for electronic review or the full committee could review electronically (in order to obtain a quorum). The electronic review process could also be an opportunity to test voting in CIM.

Jodi also discussed the possibility of requiring that a syllabus be submitted with new course proposals. Requiring a syllabus would provide more relevant information (such as assignments) and would ensure that instructors have thought through the new course completely. A syllabus draft or outline could be accepted in lieu of the full syllabus, and the final syllabus could differ from the one submitted with the proposal. The experimental course shell form currently requires a syllabus and faculty have not had issues providing the syllabus for that form. Another benefit of requiring syllabi would be having CIM as a repository for syllabi. The committee emphasized that it will be important to be clear about requirements for new course proposals (whether requiring a syllabus or making changes to the CIM form).
