I. Approval of Minutes from January 27, 2023

Motion to approve January 27, 2023 meeting minutes (Harris Houk, Lofca), motion approved.

II. MAC Competency Rubrics

- Prances provided an update on the MAC rubrics project and thanked all faculty involved in the rubric revision project. We involved over forty faculty in ten working groups. The original rubrics were drafted in spring 2020. These working groups were able to pull from their own instructional experience and area of knowledge expertise to review and update the rubrics. The working groups were given four revision parameters:
 - O The learning described at each level should align with Level 2 as "MAC competent", be strongly implied by the SLO, and be measurable.
 - o The Definition paragraph should be brief and student friendly.
 - The Framing Language paragraph should state course design and instructional expectations.
 - o The Glossary should define any technical or key concepts.

Six of the eleven rubric revisions are in, the final five will be in by the end of February. Council discussed the rubric levels/labels; should a level 0 be added? As a reminder, these rubrics are intended to be used across programs, not just in MAC. Motion to approve the following rubric descriptions/labels (Coleman, Rosenkrantz), motion approved:

Level 1 – Developing

Level 2 – MAC Basic

Level 3 - Enhanced

Level 4 - Sophisticated

Council reviewed the framing language and definition sections for the Foundations and Health & Wellness competencies. Discussion concerned the audience for each section of the rubric. Suggestion to align framing language statement across all competencies.

Frances asked members to focus comments on definition and framing language paragraphs (remaining rubrics posted in Box).
