#### IV. Informational Items

At the January 12 meeting of the Graduate Curriculum Committee, several revisions (including credit hour changes) were approved for NUR courses that are part of the Nursing, D.N.P. Post-Baccalaureate Nursing Anesthesia concentration. A program revision for the Nursing, D.N.P. Post-Baccalaureate Nursing Anesthesia concentration is proposed, effective Summer 2024. However, students currently enrolled in the concentration need to enroll in these NUR courses with the original credit hours. To accommodate these students, the Graduate School and University Registrar's Office are revising the following courses to have variable credit hours:

- NUR 758: 2-3 credit hours
- NUR 771B: 6-8 credit hours
- NUR 772: 6-7 credit hours
- NUR 773B: 6-7 credit hours
- NUR 774: 6-7 credit hours
- NUR 775A: 6-8 credit hours
- NUR 775B: 6-7 credit hours

Please note that the variable credit hours will only be in place until the current students graduate.

The Computer Science, Ph.D. has been administratively edited by the Graduate School at the request of the Computer Science department. The statement "Students who complete the M.S. program may receive a 'pass through master's' after passing phase 1 of their qualifying exam" has been removed to more accurately reflect the practices of the Computer Science department and the Graduate School.
