## VIII. IC Update

## Foundations of American Democracy Requirement (FUSS 400.1.5.II.9)

Andrew Hamilton shared that the UNC System added a new mandate to the Regulation Related to Fostering Undergraduate Student Success (FUSS), which requires the university to offer a course or courses in the Foundations of American Democracy but does not stipulate the way in which the content is offered.

## FUSS 400.1.5.II.9

UNC System policy now requires that every student who is awarded a baccalaureate degree must "successfully complete a course or courses covering the foundations of American democracy." The policy further stipulates two sets of learning outcomes that must be the course(s) "must substantively include:"

- i. Evaluate key concepts, principles, arguments, and contexts in founding documents of the American republic, including the United States Constitution, the Declaration of Independence, and a representative selection of the Federalist Papers; and,
- ii. Evaluate key milestones in progress and challenges in the effort to form "a more perfect Union," including the arguments and contexts surrounding the Gettysburg Address, the Emancipation Proclamation, and the Letter from Birmingham Jail, as well as other texts that reflect the breadth of American experiences.

This policy goes into effect for the 2025-2026 catalog.

Council reviewed the Foundations of American Democracy Requirement along with options for completing the requirement. Discussion followed:

- There is no credit requirement attached to the policy.
- Courses have not been cross walked.
- Recommended to offer this content in a 3-credit course rather than 1-credit.
- Option 1 could be offered as a NEW university requirement (new course) as it adds 3 credits to what students are already taking.
- Option 2 do not make this a new requirement, swap out an existing requirement.
- Suggestion to add a marker.
- Could this be addresses with an asynchronous online course students would take prior to orientation?
- We need to offer something that supports our students in their growth and learning.
- Add to an existing MAC competency:
  - Modify Foundations to include the FoAD outcomes. Council recently approved integration of QEP into Foundations; several departments have disciplinary based Foundation courses.
  - o Modify Diversity & Equity to include the FoAD outcomes.
  - o Replace Data Analysis (combine CTI NS & Data Analysis)
  - o Add a 12<sup>th</sup> competency.
- Is this a MAC/general education problem?
  - o The Council could decide this should not be part of the general education program.
  - o If this is not included in the MAC, a small number of departments that have expertise would create a course or work with departments to integrate the content into other courses. It would be left up to every program to figure out how to include the outcomes.
  - o We will have to assess these outcomes on a regular basis.
- We cannot extend beyond the 120 credit hours.
- Suggestion to add a new competency, adding this to an existing competency could infringe on academic freedom.
- What are other UNC System schools doing?
- The conclusion should not create an undue burden on students for completion of degrees.
