V. Academic Program Planning Ad Hoc Task Force DRAFT Phase 1 report.

UCC discussion/feedback

Committee members reviewed the Academic Program Planning Ad Hoc Task Force DRAFT of Phase I report dated August 7, 2024.

Concerns/Questions:

- The Undergraduate Curriculum Committee is mentioned in Section Two: Academic Program Review Process (suggesting the UCC plays a role int the process). In the pages that follow, describing the phases, there is no mention of UCC. What role would UCC play in this process?
- UCC could deal with curricular changes coming out of an Academic Program Review, in the normal process.
- The UCC would like to have more of a role at the beginning of an Academic Portfolio Review.
- Because the UNC System is mandating the review will have to be at the program level, there will have to be a section in the departmental review for every program delivered outside of an accrediting body by a department or school.
- Suggestion to revise the charge of UCC by the end of the year. A meeting with Senate would be beneficial to address the following:
 - o To reflect the terms "Academic Program Review" and "Academic Portfolio Review."
 - Define the role of UCC in each review.
