Chair said we are expecting 14 new MFAD proposals and several revised proposals. Andrew said we will not know how many seats we need until we find out how many students will have to take the requirement in the fall; since the proposed courses are in competencies with more seats than we need, there should not be a problem. Chair said that Council should create an approval process for these courses. Suggested options:

- Council could review proposals (competency & MFAD)
- Create a sub-committee to make recommendations to Council.
- Invite faculty with expertise in the subject to advise Council on the SLOs.

Suggestion to go with bullet 3 to help design the approval process/materials as soon as possible. Many of these courses are coming from departments with disciplinary expertise. Council will continue the discussion at their next meeting.
