V. Diversity & Equity competency (Andrew)

Resolution to Faculty Senate

Andrew shared that the Council should create a plan preemptively to address possible changes to the Diversity & Equity competency in the general education program. Discussion followed:

- Program Directors of African American and African Diaspora Studies and Women's, Gender, and Sexuality Studies are involved in the ongoing conversations.
- Communication to Senate will be informational at this time.
- We understand that this competency is important to our student body.
- How can we make changes in meaningful ways to uphold our identity and vision?
- We now have two anti-student success measures.
- Recommendation to allow Andrew Hamilton and Jessica McCall take to the Senate an informational item about the state of the Diversity and Equity competency. We want to do our best to think about what our next steps are in an informed way that includes all voices involved.
- The Senate should expect a resolution from Council that says we are going to have a reevaluation of the competency based on external actions and we will make recommendations on a timeline (by the end of spring semester).
- Council members are encouraged to attend the February 5th Senate meeting.
- What is the anticipated outcome?
- Council will support African American and African Diaspora Studies and Women's, Gender, and Sexuality Studies.
- Student perspectives must be central to the conversation.
- Examples we should utilize are schools that are very similar to UNCG. We should control the narrative.
- There is no directive at this time.
- A contingency plan is needed. if an imposed change happens over the summer.
