UCC tabled (1) summary explaining how this is a Sociological treatment of this topic and how this course fits in the Sociology program (2) revised course description that does not include the required 'Foundations' documents. Response received (UCC will vote electronically next week).

IV. New Civics and Community competency

- Faculty Senate update
- Existing courses with MDEQ attribute
- Existing courses with MFAD attribute

Council discussed review of courses for the new competency. Chair advised that it was decided to use the critical thinking learning outcomes which are very broad, within Civics & Community, and include the Foundations of American Democracy outcomes. We have not yet approved a full description or rubric. The idea is to keep the competency broad enough to meet the needs of a variety of different courses.

As we measure any course now, we will look at the four outcomes:

- 1. Critically analyze claims, arguments, artifacts or information.
- 2. Construct coherent, evidence-based arguments.
- 3. Evaluate key concepts, principles, arguments, and contexts in founding documents of the American republic, including the United States Constitution, the Declaration of Independence, and a representative selection of the Federalist Papers; and,
- 4. Evaluate key milestones in progress and challenges in the effort to form a more perfect Union, including the arguments and contexts surrounding the Gettysburg Address, the Emancipation Proclamation, and the Letter from Birmingham Jail, as well as other texts that reflect the breadth of American experiences.

Chair provided an update on the progress of the MDEQ crosswalk. Departments were asked to select a new competency for these 45 courses; crosswalk to the new competency will be effective summer 2025. Suggestion to review the updated syllabi for cross walked courses to ensure the new competency content and outcomes are included. We will collect and review syllabi in August. Andrew will ask UTLC to provide support for faculty moving to new competencies. Existing courses with MFAD attribute will be moved to the new Civics & Community competency unless they choose to opt out. If the course had been previously offered with a competency (other than MDEQ), a new course number will be required.

Dana shared that the Registrar's Office has removed the MDEQ requirement, in DW, from all MAC catalogs (2021-2024). Degree Works evaluations will not show any MDEQ requirement, these courses were shuffled to the next best fit (i.e. CIC, major requirement, or general elective).

Council will review and vote electronically on tabled proposals.
