The Graduate Curriculum Committee commented that the Occupational Therapy, M.S.O.T. has a high number of credit hours compared to many master's programs at UNCG. Dean Mattacola reported that the Occupational Therapy, M.S.O.T. is a clinical program and that the number of credit hours is comparable to other occupational therapy master's programs. Dean Mattacola stated that the program may also be modified when the program coordinator is hired. The GCC inquired if the Occupational Therapy, M.S.O.T. would ever be offered online, and Dean Mattacola indicated that the program is very hands-on and is designed to be completed mostly in-person. Dean Mattacola also stated that an updated financial worksheet will be available and that the program will focus on in-state students. He shared that the program may be able to collaborate with Community and Therapeutic Recreation and other departments but that the courses will be taught by new faculty credentialed in Occupational Therapy.
